In conformance with City Council Policies and Procedures:

Comments and/or Requests from the Public

Chapter 6, Section 6.7 of the Westland City Charter states, “Citizens shall have a reasonable opportunity to be heard.” Section 15.263(5) of the Michigan Open Meetings Act provides that persons shall be permitted to address the meeting of a public body under the rules established by the public body, and also provides that the public body may limit the right to address the public body to prescribed times. Council hereby establishes a three (3) minute time limit for speakers under these three (3) categories:

(1) Questions or Input on Agenda Items from the Public

This section will allow a person to be recognized only at the beginning of the meeting to address the Council pertaining to items that are specifically on the business agenda. Questions asked may be responded to during the agenda item following a motion and support from the Council.

(2) Comments and/or Requests from the Public

This section will allow a person to be recognized at the conclusion of the Council’s regular business to make general comments that may or may not pertain to the business that was before Council at that meeting.”

(3) All Open Study Sessions

Public Hearings – Any person may additionally speak once at a public hearing for three (3) minutes. Discussion is confined to the Public Hearing topic.

Everyone speaking before the Council should do so in a civil manner. Speakers should refrain from abusive or profane remarks, vulgar language, disruptive outbursts, threats, racial slurs which do not promote civil discourse or other conduct that interferes with the business meeting. Personal attacks on Council Members, the Administration, City Staff, other

speakers, or members of the public do not promote civil discourse. The clock will start upon the first words of the speaker and will not stop while the speaker is recognized from the floor. It is the speaker's option to ask questions at this time, and the person questioned may choose to respond during the speaker's allotment of time, however, the clock will not be stopped once it is started. The clock will continue to run until the speaker is completed or their speaking time is exhausted, whichever is first.

There will be no separate discussion of these items unless a Council member so requests, in which event, the item will be removed and considered in its normal sequence on the agenda.

AGREEMENT

THIS AGREEMENT made and entered into this ____ day of _____, 2026, by and between the CITY OF WESTLAND, a Michigan Municipal Corporation of the State of Michigan, (hereinafter referred to as "CITY"), the address of which is 36300 Warren Road, Westland, Michigan 48185, and WAYNE-WESTLAND COMMUNITY SCHOOLS (hereinafter referred to as "SCHOOL DISTRICT") whose address is 36745 Marquette, Westland, Michigan 48185, both of whom agree and understand as follows:

WITNESSETH:

WHEREAS, the CITY and the SCHOOL DISTRICT believe in a proactive approach to crime, deterrence and innovative education; and,

WHEREAS, the parties are interested in strengthening the relationship between the CITY, SCHOOL DISTRICT and students who attend John Glenn High School in the CITY OF WESTLAND.

NOW, THEREFORE, the parties hereto agree as follows:

1. The CITY shall provide an experienced police officer to the SCHOOL DISTRICT to perform as a counselor, liaison and positive role model for the students at John Glenn High School (hereinafter referred to as "JGHS").
2. The Chief of Police and the Principal of JGHS shall consult and agree as to the specific role, work schedule and logistics of the police officer assigned. The Mayor shall approve the police officer assigned.
3. The relationship between the SCHOOL DISTRICT and the CITY shall be that of independent contracting parties. The CITY shall be self-directed in its activities (provided the CITY shall abide by the terms of this Agreement). The CITY shall determine its own methods and manner for performing the services to be provided under this Agreement within the overall policies and rules established by the SCHOOL DISTRICT as the same may be amended by the SCHOOL DISTRICT from time to time. The CITY shall remain solely responsible for determining the means and methods of performing services under this Agreement. The police officer assigned by the CITY to JGHS shall at no time represent himself or herself to be an employee, servant or agent of the SCHOOL DISTRICT. The police officer shall remain an employee of the CITY and not that of the SCHOOL DISTRICT at all times relevant hereto.
4. The ultimate responsibility for and control of the police officer shall remain with the Chief of Police for the CITY OF WESTLAND.
5. The police officer shall dress in plain clothing or uniform and work a flexible and mutually agreed upon schedule that will allow the officer to attend as many extra-curricular events as possible.

COMPENSATION

6. The SCHOOL DISTRICT shall reimburse the CITY fifty (50%) percent of five-sixths (5/6) of the cost for said officer, provided, however, that the police officer performs the duties assigned at JGHS. "Cost" is defined as the exact amount of the payroll plus fringe benefits that the officer assigned to JGHS earns. Reimbursement shall include, but not be limited to, basic salary, health insurance, dental insurance, life insurance, clothing allowance, proficiency allowance, unemployment insurance, workmen compensation insurance and participation in the CITY's pension plan. The CITY shall bill the SCHOOL DISTRICT in ten (10) periods annually, and the SCHOOL DISTRICT shall remit payment thereafter.
7. In the event that the officer is requested to work overtime by the SCHOOL DISTRICT, the cost of that overtime payment, as well as fringe benefits, shall be paid by the SCHOOL DISTRICT.
8. In the event that the officer is unable or unwilling to perform such duties for all or a portion of any given month, and the CITY is unable or unwilling to provide a replacement officer, then the SCHOOL DISTRICT shall be only responsible for a "pro rata" share of the costs listed above for services actually provided.

TERM

9. The term of this Agreement shall be for a period of one (1) year from the date this Agreement is signed by both parties, renewable annually by agreement of the parties in writing. The Agreement will be reviewed annually before renewal and at any other time if deemed necessary by either party. However, in the event circumstances should change beyond the intent or control of the parties, as described herein (by way of example and not limitation: an emergency situation arises in the CITY which would require the use of the police officer for a prolonged period of time as determined by the CITY or the presence of a police officer in the school setting becomes disruptive to the educational process of the students as determined by the SCHOOL DISTRICT), then this Agreement may be terminated upon thirty (30) days written notification by either party. It is not the intent of either party, however, to terminate this Agreement for financial reasons.

MISCELLANEOUS

10. The CITY to the fullest extent permitted by law shall indemnify, defend and hold harmless the SCHOOL DISTRICT from and against all penalties, fines, damages, sanctions, losses, assessments, liabilities, claims, costs, obligations and other expenses (including reasonable attorneys' fees), whether or not resulting from

third-party claims (collectively "Losses"), arising out of any act or omission of the CITY and any breach or other default of any agreement, representation, warranty or covenant on the part of the CITY contained in this Agreement or the provision of any of the services contemplated by this Agreement.

The SCHOOL DISTRICT to the fullest extent permitted by law shall indemnify, defend and hold harmless the CITY from and against all penalties, fines, damages, sanctions, losses, assessments, liabilities, claims, costs, obligations and other expenses (including reasonable attorneys' fees), whether or not resulting from third-party claims (collectively "Losses"), arising out of any act or omission of the SCHOOL DISTRICT and any breach or other default of any agreement, representation, warranty or covenant on the part of the SCHOOL DISTRICT contained in this Agreement or the provision of any services contemplated by this Agreement.

11. All notices and other communications shall be effective upon receipt if hand delivered, shall be effective three (3) days after depositing in the U.S. mail and shall be effective one (1) day after sending by a nationally recognized overnight delivery service to the addresses stated below or to such other addresses as to which any party shall have previously notified the other parties in writing in conformity with this Section. For the purposes of this Section, the addresses of the parties shall be as set forth in the preamble of this Agreement.
12. This Agreement constitutes the complete agreement between the parties and supersedes and replaces all prior negotiations and agreements. There are no representations, warranties, covenants, conditions, terms, agreements, promises, understandings, commitments or other arrangements whether express or implied other than those expressly set forth or incorporated herein or made in writing on or before the date of this Agreement.
13. This Agreement will be governed by and construed in accordance with the laws of the State of Michigan applicable to contracts made and to be performed entirely within such state and without giving effect to choice of law principles of such state. Each of the parties agrees that any legal or equitable action or proceeding with respect to this Agreement or entered into in connection with this Agreement or transactions contemplated by this Agreement shall be brought only in any court of the State of Michigan or in any court of the United States of America sitting in Michigan and each of the parties submits to and accepts generally and unconditionally the jurisdiction of those courts with respect to such party's person and property and irrevocably consents to the service of process in connection with any such action or proceeding by personal delivery to each party at such party's address as set forth in this Agreement or in the manner set forth in this Agreement. Nothing in this Section shall affect the right of any party to serve process in any other manner permitted by law.

14. Except as otherwise specifically provided herein, each of the parties hereto shall pay its respective counsel fees, accounting fees and other costs and expenses incurred in connection with the performance of this Agreement.
15. This Agreement is made solely for the benefit of the parties to this Agreement. Nothing contained in this Agreement shall be deemed to give any person, partnership, joint venture, corporation, limited liability company, governmental authority or other entity any right to enforce any of the provisions of this Agreement nor shall any of them be a third-party beneficiary of this Agreement.
16. The failure of any party to exercise or enforce any right or remedy conferred upon it hereunder shall not be deemed to be a waiver of any such or other right or remedy nor operate to bar the exercise or enforcement of any right thereof at any time thereafter.
17. The police officer will attend restorative practices training as provided by the district.
18. The police officer's employment records, including but not limited to hours worked and rate of pay, will be maintained by the City of Westland Police Department.
19. The SCHOOL DISTRICT will provide an office at JGHS for the police officer and access to MI-Star for the police officer. All police equipment for the police officer at JGHS will be provided by the CITY.



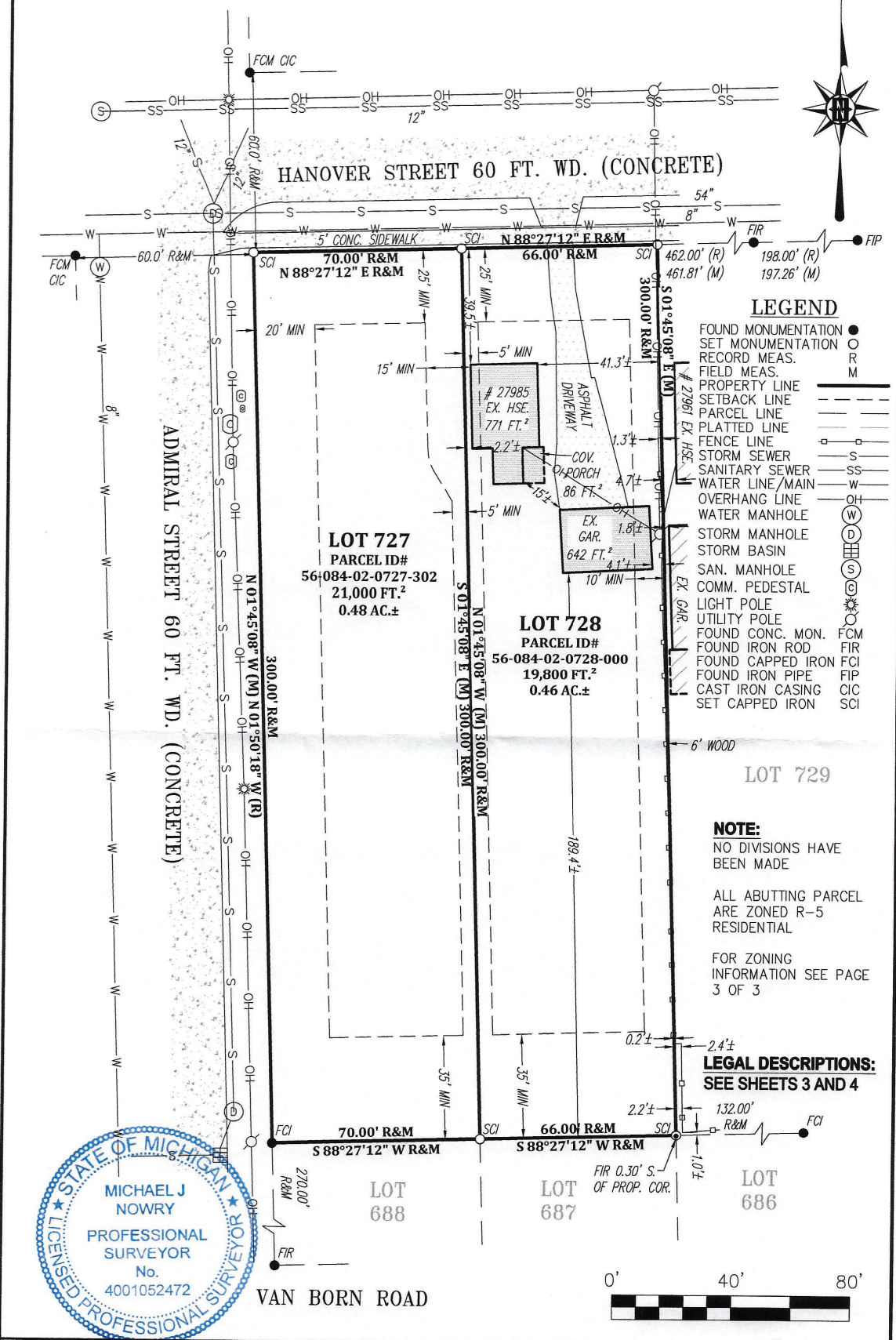

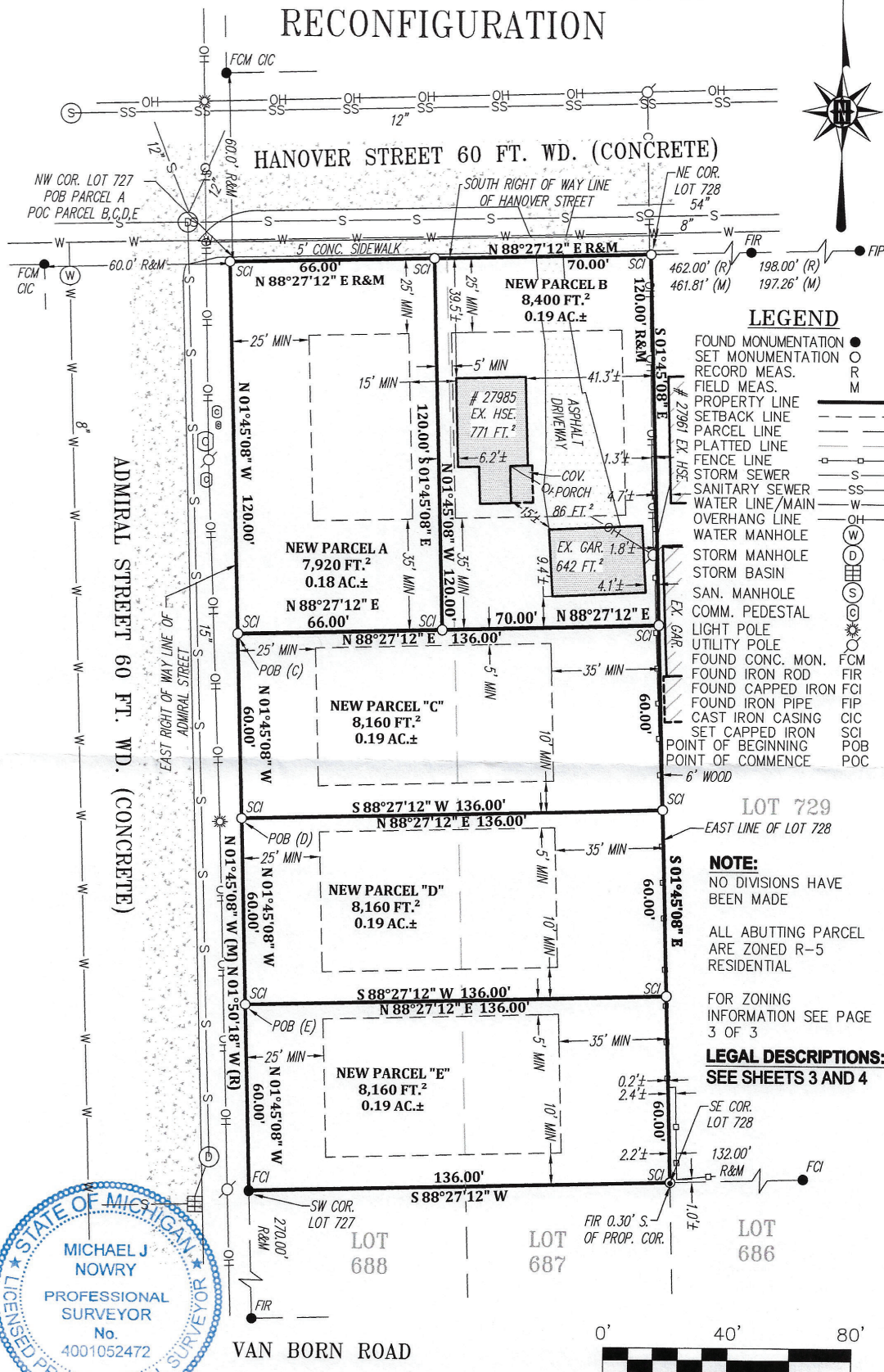

No problem you can send the following:

"The property that the taxpayer purchased from the Land Bank is on a specific tax roll separate from the property they already own (ad valorem tax roll). The Land Bank property will be taken off the specific tax roll on December 31st on the fifth year following the sale. The Land Bank receives 50% of all property taxes paid in those five years. Therefore, we cannot remove the parcel from the specific tax roll due to lost revenue. This law grants land bank authorities a mechanism for generating revenues on properties that have been transferred to private ownership, in turn providing that authority critical resources to fuel its mission of returning other properties to productive use.

The only option is to pay the total tax disbursement directly to the land bank. This amount equals the annual tax disbursement for five years, which reflects the total revenue that the WCLB would have collected."

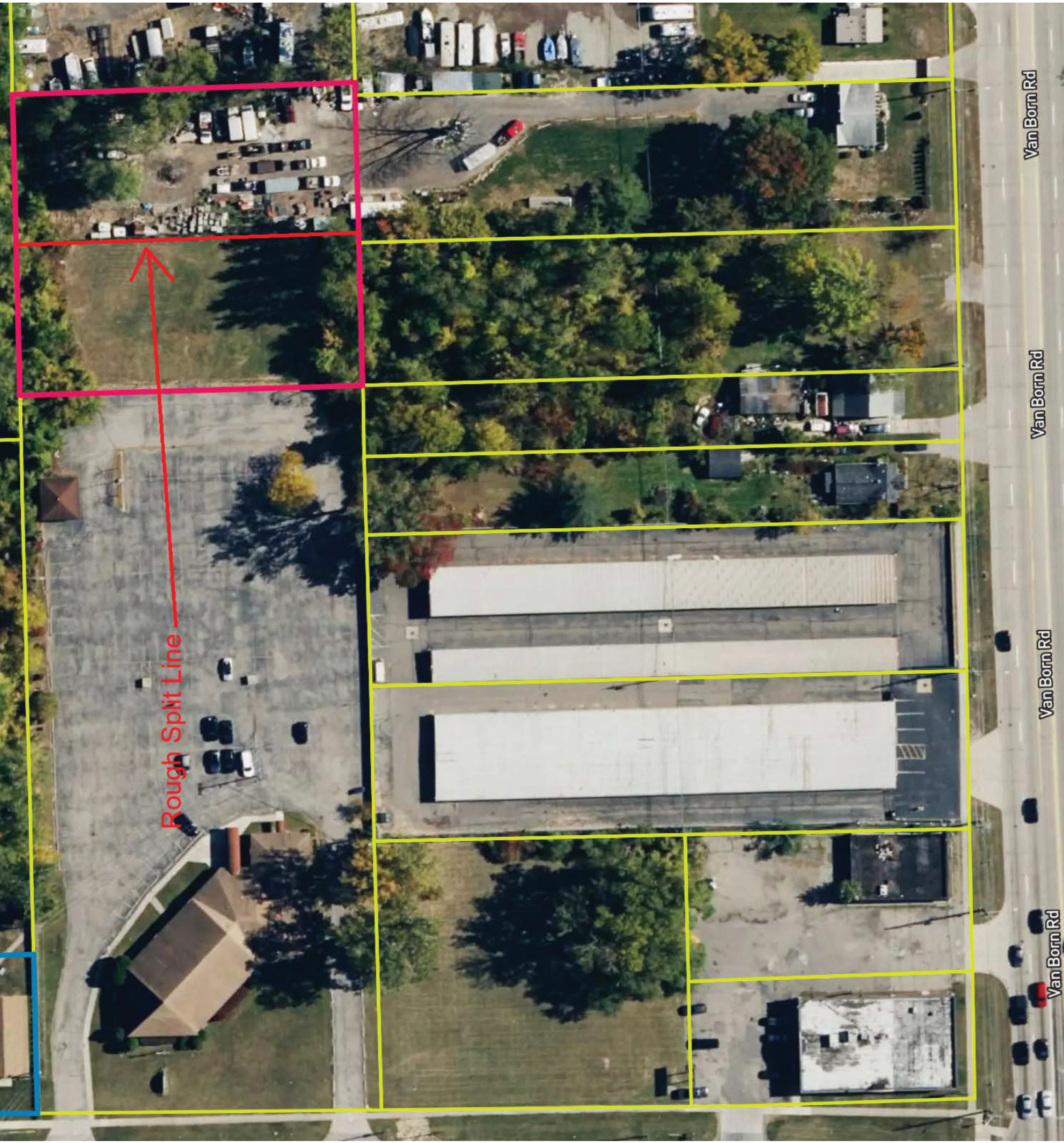

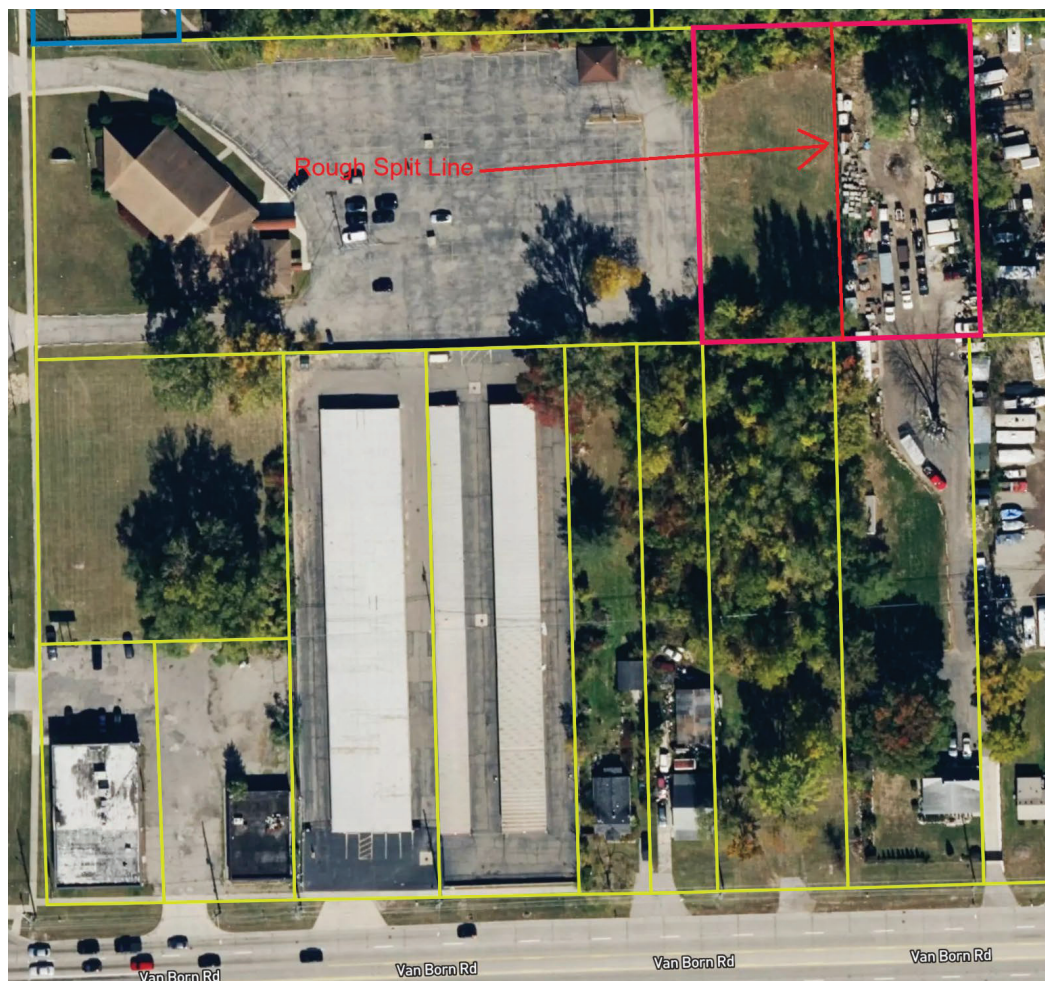
