Mayor William R. Wild Announces Several Board and Commission Appointments

Westland, MI (May 19, 2021) Mayor William R. Wild announced the following appointments to the Commission on Aging, Disability Concerns Committee, Downtown Development Authority, Diversity, Equity & Inclusion Commission, Economic Development Corporations/ Tax Increment Finance Authority/ Brownfield Redevelopment Authority, Westland Historical Commission, Local Development Finance Authority, Municipal Services Bureau, Parks & Recreation Advisory Council and Youth Assistance Advisory Council.

Commission on Aging

Desmond Jackson has been reappointed to a two-year term expiring April 2023. Mr. Jackson has served on the Commission on Aging since October 2018. Mr. Jackson has brought innovative programs to the Friendship Center and is very involved in the community.

Mel Tockstein has been reappointed to a four-year term expiring February 2025. Mr. Tockstein has served on the Commission on Aging since September 2005. Mr. Tockstein is the chairperson of the Commission on Aging.

The Commission on Aging assists the Senior Resources Department Director in promoting the enrichment of the lives of senior citizens.

Disability Concerns Committee

Lisa Kurzynski has been appointed to the Disabilities Concerns Committee for a term expiring July 2022. Ms. Kurzynski will be bringing her personal life experiences to this board. She is an employee at Trinity Health and furthering her education in the medical field.

Downtown Development Authority

The Downtown Development Authority (DDA) promotes and facilitates plans that result in continued development, redevelopment, revitalization, and/or reuse of properties within the DDA district boundaries.

Economic Development Corporation (EDC)/Tax Increment Finance Authority(TIFA)/ Brownfield Redevelopment Authority(BRA)

Selvan Murugan has been appointed to serve on EDC/TIFA/BRA for a term expiring September 2021. Mr. Murugan is a Regional Chief Nursing Officer of Prime Health Care, Inc.

Andrew Ward has been appointed to serve on EDC/TIFA/BRA for a term expiring March 2023. Mr. Ward is employed at University of Michigan Multi-Ethnic Student Affairs as a Program manager.

The Economic Development Corporation/ Tax Increment Finance Authority/ Brownfield Redevelopment Authority were combined to facilitate and coordinate the work of improving and redeveloping properties throughout the City for the betterment of its residents and businesses.

Westland City Council confirmed these positions at the May 17, 2021 Council Meeting.

Westland Historical Commission

Brett Mahaffey has been appointed to the Westland Historical Commission for a term expiring in November 2023. Mr. Mahaffey works for Renewal by Anderson as a Permit and Inspection Coordinator. He has been a Westland resident for 3 years.

Local Development Finance Authority (LDFA)
