

# **MASTER LICENSE FEE SCHEDULE**

## **AMUSEMENTS AND ENTERTAINMENTS**

### **(Mechanical & Electronic Amusement)**

1. Pool or billiard room, per table, annually \$27.00

There is also a \$21.00 background check added to the license fees.

2. Public entertainment
  - a. Carnival and/or circus flat fee \$535.00
  - b. Concession stand or amusement stand, per week \$11.00
  - c. Outdoor amusement areas or amusement places maintaining or operating five or less than five kinds or varieties of exhibits, shows or amusements, annually \$215.00
  - d. Outdoor amusement areas or amusement places maintaining or operating six or more than six kinds or varieties of exhibits, shows or amusements, annually \$321.00
  - e. Outdoor movies, annually \$107.00
  - f. Any public entertainment or amusement for which pay is demanded or received, not included above, per day \$11.00
3. Mechanical and electronic amusement devices, fee for return of each confiscated amusement device \$107.00

Original licenses will be issued, and owe the balance of the license year at a reduced fee, that only applies to the per device fee and not to the application fee or any reinspection charge.

7. Change of location, inspection of each premises \$27.00
8. Bond \$1000.00-Public Entertainment License

## **ANIMALS**

1. Sale of pets, annual license \$54.00
2. Kennel license:
  - a. Private kennel, annual license \$27.00
  - b. Boarding kennel, annual license \$54.00

There is also a \$21.00 background check added to the license fees.

## **CHRISTMAS TREE SALES**

1. License fee \$54.00
2. Bond \$200.00

There is also a \$21.00 background check added to the license fees.

## **COLLISION, BUMP AND PAINT SHOPS**

1. License issuance or renewal annual fee \$54.00

## **FOOD TRUCKS**

1. License fee \$150.00

## **GOING OUT OF BUSINESS**

A fee of \$50.00 shall accompany an application for the license and for the renewal of a license, unless the clerk of the city, village, or township receiving the application waives that fee.

## **JUNKYARDS**

1. License annual fee \$214.00

There is also a \$21.00 background check added to the license fees.

## **LIQUOR**

Each applicant for a new license or permit, for transfer of an existing license or permit, for expansion of an existing establishment, and for renewal of an existing license or permit shall pay a nonrefundable application investigation fee. Such fee will be in addition to any fee required by the MLCC and shall be set by a city council resolution that shall be renewed annually. License annual fee \$1605.00

## **MARIJUANA BUSINESSES**

The applicant shall pay a fee of \$5000.00 per license type to defray the administrative and enforcement costs associated with the operation of marijuana businesses within the city. Each stacked license and excess marijuana grower license shall require the payment of a separate \$5000.00 fee.

## **MASSAGE PARLORS**

1. Licenses:
  - a. Operator's license; application annual fee \$214.00
  - b. Each practitioner or instructor annual fee \$27.00
  - c. Each apprentice annual fee \$27.00

There is also a \$21.00 background check added to the license fees.

## **PRECIOUS METALS AND GEMS SALES**

A dealer shall apply to the city clerk for a certificate of registration, and pay an annual fee not to exceed \$54.00 to cover the reasonable cost of processing and issuing the certificate of registration.

## **SECONDHAND DEALER**

The legislative body of any city, or the trustees and chief executive officer of any county or village, shall establish the fee for processing and issuing a license in accordance with its charter or local ordinance, based on the cost of issuance and administration of that license. \$535.00 annually

## **SOLICITORS, CANVASSERS AND PEDDLERS**

1. License annual fees:
  - a. Individual (including I.D. card) \$27.00
  - b. Firm, partnership, association, company or other organization \$107.00
  - c. Local nonprofit organization No fee
  - d. Duplicate copies of licenses \$2.00
  - e. Identification card \$6.00

Inspection fees for non-accessory temporary structures for each day of sales in excess of three days, per day \$105.00

There is also a \$21.00 background check added to the license fees.

## **STREET VENDORS**

1. License annual fees:
  - a. For each vehicle \$80.00
  - b. For each street vendor who does not intend to use a vehicle \$27.00
  - c. For each helper or assistant to a street vendor who intends to use a vehicle \$27.00
  - d. For identification badges \$6.00
  - e. Vehicle reinspection \$11.00

There is also a \$21.00 background check added to the license fees.

## **TEMPORARY SALES/TEMPORARY STRUCTURES**

License and review fee for temporary sales from accessory or non-accessory temporary structures (retail stands, tents, canopies and other membrane structures) \$476.00

Inspection fees for non-accessory temporary structures for each day of sales in excess of three days, per day \$105.00

## **USED CAR DEALERS**

1. License annual fee \$214.00
2. Bond \$5000.00
