Application for the Westland Rotary Canine Corral must be submitted online or in person, with fee, City of Westland dog license, vaccinations certificate including Distemper (DHLP) and rabies, and proof of spayed/neutered dog. Applicants are required to be Westland residents, submit documentation online or in person, and receive approval from the City prior to obtaining a fob for the Dog Park.

The yearly fee is \$30 for Westland residents. The annual fee will run March 1st through March 1st of the following calendar year.

To the fullest extent permitted by law, I/we agree to indemnify, defend, pay on behalf of, and save harmless the City of Westland and its elected and appointed officials, consultants, agents and employees from and against all loss or expense (including costs and attorney's fees) by reason of liability imposed by law upon the City or its elected and appointed officials, consultants, agents and employees for damage to property, damages because of bodily injury, including death at any time resulting therefrom, sustained by any person or persons arising out of or in consequence of I/we's or our dogs' use of the park or arising from or connected with the use or misuse of the admittance key fob issued in conjunction with this application for the Westland Dog Park Privileges, whether such injuries to person or damage to property is due or claimed to be due to I/we's negligence, or the City, its elected and appointed officials, consultants, agents or employees' negligence, except only such injury or damage as shall have been occasioned by the sole negligence of the City, as judicially determined.

Waiver/Release of Liability & Assumption of Risk Acknowledgement ("Waiver")

I (we) agree, to the fullest extent possible under law, to hold the City of Westland, their members, directors, officers, elected and appointed officials, consultants, agents, volunteer employees, harmless from any claims for loss or injury that are or may be alleged to have been caused, directly or indirectly, to any person or real or personal property, including dogs, by the actions of myself, my authorized users, my guests, assigns, or agents, including anyone using my access code or key fob to enter the Westland Rotary Canine Corral Dog Park ("Dog Park"), my dog(s), or any dog(s) brought by my authorized users, my guests, assigns, or agents, including anyone using my access code or key fob to enter the Dog Park, while on the real property located at 37091 Marquette Street, Westland, MI 48185, including in and around the fenced in Dog Park located thereon ("Grounds"), and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of our dog(s) by disappearance, theft, death or otherwise, and from any claim for damage or injury to our dog(s), whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the City of Westland or any of the parties aforementioned. I (we) understand that there are inherent risks in the use of a dog park, and fully assume all risks involved in the use of the dog park on the Grounds. Risks may include, but are not limited to, injury or damage caused directly or indirectly as a result of dog fights, dog bites, being knocked down, chased or tripped, dog(s) being hit by a motor vehicle, and other similar risks. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless or this unsupervised facility from any and all loss and expense (including legal and expert witness fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of any of the aforementioned risks. I agree to carefully inspect and satisfy myself (ourselves) that the Grounds and Dog Park facilities provided are safe for their intended use. Once having conducted the inspection, I (we) agree to expressly assume all risks for myself, guardians, my children, and my dog(s) participating at these premises. By my signature below, I state that I (we): 1) agree to the terms and conditions described herein, 2) have read and fully understand the Dog Park Rules and Regulations (and will explain the same to attending children and guests), and 3) promise to comply fully with all of the conditions of the Dog Park Rules and Regulations and this Waiver. I (we) understand that violation of the Dog Park Rules may result in suspension or revocation of Dog Park privileges. I (we) also agree to immediately report any unsafe property conditions to the Westland Parks and Recreation office at Westland City Hall, located at, 36300 Warren Road Westland, MI 48185, call (734) 722-7620 during the open hours, or email parks@cityofwestland.com.

I/WE HAVE READ THE CONDITIONS EXPLAINED IN THIS WAIVER AND AGREE TO ABIDE BY THEM. I/WE ALSO UNDERSTAND AND ACCEPT THAT THE RULES MAY BE CHANGED FROM TIME TO TIME AND UNDERSTAND THAT ANY CHANGES WILL BE POSTED AT THE DOG PARK.

City of Westland Parks and Recreation Department WESTLAND ROTARY CANINE CORRAL Rules and Regulations

- Dog(s) must be licensed through the City of Westland.
- The Dog Park is for City of Westland residents that have a current registration for their dog(s).
- Dog(s) are required to wear a collar with current license and vaccination tags.
- Maximum of 3 (three) dogs per household on application.
- Maximum of 2 (two) dogs per owner/handler per visit.
- No female dog(s) in heat allowed in the Dog Park.
- Dog(s) required to be spayed/neutered to be allowed within the Dog Park.
- Dog(s) required to be current with their required vaccinations to be allowed within the Dog Park. The City of Westland reserves the right to check vaccination records for any dog(s) at any time, which the owner(s)/handler(s) agrees to comply with.
- No dog(s) under 4 (four) months allowed in the Dog Park.
- Aggressive dog(s) are not allowed and any dog(s) exhibiting aggression must be removed by owner(s)/handler(s) immediately. Aggression can include, but is not limited to, the following: guttural barking, lunging, showing teeth, and snarling.
- Dog leash laws apply up to the Dog Park fenced boundaries; see Westland Code of Ordinances Sec. 66-9 – Domestic Animals.
- Dog leashes must be removed once inside double gate (entrance); dog(s) shall not wear leashes inside the Dog Park for their own safety.
- Dog(s) shall not be left unattended at any time.
- Owner(s)/handler(s) must be 16 years or older and be able to control their dog(s) at all times.
- Owner(s)/handler(s) must fill in any holes dug by their dog(s).
- Owner(s)/handler(s) must pick up and dispose of any solid dog waste immediately into the provided dog waste receptacles.
- No food or treats, for humans or dogs, are allowed in the Dog Park.
- Alcohol is not allowed in the Dog Park.
- No dog toys are allowed in the Dog Park.
- Dog Park hours are clearly posted at entrance of Dog Park and are to be followed.
- No unaccompanied minor(s) allowed in the Dog Park and no children under the age of 5 allowed in the Dog Park regardless of supervision.
- No excessive shouting by dog owner(s)/handler(s) or other behavior that can result in an aggressive response by the dog(s) in the Dog Park.
- Owner(s)/handler(s) shall not commit any offenses against the public peace under Article IV of the Westland Code of Ordinances while in the Dog Park, including unreasonably loud, disturbing, or unnecessary noise.
- **Owner(s)/handler(s) MUST have reasonable control over their dog(s), including voice control.**

There is a posted procedure for reporting violations of posted rules or of dog bites or other emergencies that occur within the park (may include notice to call WLPD).
